Every member assumes the risk of personal injury; illness or other medical conditions arising out of or related to the member's activities on YMCA premises, and releases the YMCA, its directors, officers, agents and employees, from all claims, actions or liability on account of such causes. - Monthly memberships may be discontinued at any time with **written notice before the 25th** of the month you wish to cancel. Cancellation notices received after the 25th will be effective the last day of the following month. Annual memberships may be discontinued by written notice only effective as of the end of the membership year, and there will be no refund of prepaid fees, except for compelling medical reasons as determined by the YMCA management, in its discretion, or when a member is moving outside a fifty-mile radius of Staunton, Virginia. Member(s) may put their membership on medical hold for up to six months with a physician's notice. Permanent cards must be turned into the membership office when notice is given to terminate or put membership on hold. Temporary cards will be provided to use until membership is discontinued. (Please Initial _____)
- Errors or questions regarding monthly payments must be identified to the business office no later than 60 days from billing date. Should any monthly draft not be honored members are still responsible for that payment plus a \$20.00 service charge applied by the YMCA. (Please Initial _____)
- The YMCA's Board of Directors may, at their discretion, adjust the monthly fee applicable to my category of membership on not less than thirty days prior notice to me. Annual and semi-annual memberships will be adjusted at the end of the membership year. (Please Initial _____)
- Each member will be issued a membership card, which **must** be presented, for admittance to YMCA facilities. The membership card is not transferable. Loan of a membership card may result in cancellation of membership. The YMCA reserves the right to charge a fee for replacement of lost cards. If a membership is canceled for any reason, or a member elects to terminate, all membership cards must be returned to the YMCA as of the date of cancellation or notice of termination. Photo Id. is required if you do not have your membership card. (Please Initial _____)
- Membership may be terminated if**, in the opinion of the YMCA management, a member or member's guests commit misconduct, within or outside the YMCA, destroy YMCA property, falsify this membership application, commit theft, whether prosecuted or not, or failed to pay any fees when due.
- Every member is solely responsible for safeguarding the member's personal property at all times, and releases the YMCA from any liability on account of loss or destruction of personal property. Locks are available at the front desk.
- Use of YMCA facilities is subject to all rules and regulations adopted by the YMCA. Failure to follow these rules may result in termination of membership (**see membership guidelines**). (Please Initial _____)
- Youth members under the age of 12 do not have facility privileges unless they are accompanied by an adult YMCA member over the age of 18 or are in a supervised program. (Please Initial _____)
